## TEMPORARY REMOVAL OF WALTER STREET ROAD CLOSURE

As you are aware, construction works associated with the King William Road Upgrade are well underway. One of Council's key commitments is to minimise disruptions for traders during construction including the impact regarding the loss of parking.

There are approximately forty-two (42) off-street parking spaces located to the rear of the businesses which are situated at the corner of Walter Street and King William Road. These car parks are used by shoppers, traders, visitors and a number of residents who reside above some of the businesses located in this area. During some of the stages of construction works access into and out of Walter Street from King William Road will restricted and in turn, access to and from the off-street car parks off Walter Street will also be restricted.

Currently, there is a road closure in place immediately to the west of the off-street parking areas which prohibits drivers travelling from King William Road through to Royal Avenue. To enable access to and from the off-street car parks, approval has been granted to Council's contractor (BMD Construction Pry Ltd) to temporarily remove this road closure. However, I wish to be clear that once access to and from King William Road is no longer restricted by the construction works, the permanent road closure will be reinstated. The reinstatement will include the replanting of trees, paving, bollards and all other infrastructure as required.

Figure 1 below outlines the locality of the off-street car parks and the road closure which will temporarily be removed during construction works.

In other words, drivers will only be permitted to travel through the removed road closure to access the off-street car parks whenever they are unable to do so via King William Road.

In term of timing, the removal of the road closure is expected to occur in approximately one (1) week from the date of this letter. The project schedule is subject to weather conditions and in the event there are delays or changes you will be contacted and advised accordingly. With that in mind, I advise that it is anticipated that the road closure will be permanently reinstated by no later than the end of November 2019.
